1. **AGE LIMIT** 35 years maximum as on the last date of submission of application.

**NOTE: Only Date of Birth indicated in School Leaving Certificate or equivalent Certificate will be accepted. No subsequent request for change shall be granted.**

2. **SELECTION PROCEDURE**

Selection will be on the basis of performance in the Screening test/Interview.

### **NOTE**

(i) In case response is high, the Institute reserves the right to restrict the number of candidates to be called for interview to higher percentage of marks in the requisite qualification and or to conduct a screening test of the eligible candidates. The decision of the Institute in this regard will be final and binding.

(ii) SC/ST outstation candidates called for interview will be paid to & fro Travelling Allowance of 2<sup>nd</sup> class railway fare by the shortest route (subject to production of tickets) as per rules. However, Travelling Allowance is not admissible to those SC/ST candidates who are already in Central/State Government Services, Central/State Government Corporation, Public Undertakings, Local Government Institutions and Panchayat and the concession availed from Railways, if any, for undertaking journey for attending Interview.
